

District Heating Conference 9-11 May, 2022 Brasov, Romania



District heating is the hot topic to be debated on 9-10th November, 2021, in Brasov. Will you join us to find out how to address the green agenda through district heating?

The event is organised by DBDH in cooperation with the COGEN Romania and the Royal Danish Embassy in Bucharest. The event aims to build a valuable relation between DBDH members and COGEN Romania, providing the attendants with access to the important decision makers in the Romanian sector for district heating.

Why Participate?

Romania's leadership did not have DH on the agenda for some time, but things are about to change. Being a member of EU, Romania must put focus to energy efficiency, which can be accomplished with the help of DH.

The Romanian energy strategy is quite clear, as district heating will continue to be necessary in parallel with the support schemes available for cogeneration capacity, especially in the country's larger cities. It is necessary to upgrade and develop the existing infrastructure that

has become unsustainable, to elaborate a support mechanism that will allow investments in infrastructure or based on efficiency of use resources, as well as to update the framework regulation to ensure flexibility, coherence, predictability and bankability.

Given the European agenda on climate change and its own aspirations, Romania is keen on improving these aspects and is willing to invest in the right strategy and products.

Opportunities to be highlighted:

- 1,4 million appartments across Romania still use DH, serving about 4 million people (Bucharest 50-52% coverage)
- Bucharest General City Hall is investing 230 mio Euro in an ecological waste-based incineration plant for energy
- 47 cities are still using DH, and are seeking to develop and improve their systems
- Some cities are looking to invest in RES (solar, biogas, geothermal)
- New law make it difficult to disconnect from DH, which will help the DH sector

Whom will you meet?

The two-day event in Romania is a top-level meeting with decision makers and the technical staff of all relevant district heating companies in Romania. It also aims to engage with the high-level government officials involved in financing promising projects and initiatives.

The district heating sector in Romania can benefit tremendously from the expertise and technologies of Danish companies involved. Thus, the objective of this event is to bring together the Romanian and Danish district heating sectors and create new possibilities for all the involved parts.

Participation includes

- Meeting relevant managers of Romanian Heating plants as well as leaders and decision makers in the Romanian municipalities
- Members of the Romanian Ministry of Energy as well as Ministry of Regional Development will be invited to the event
- Getting complete access to the Romanian district heating and utility sector executives.
- Presenting your technology and solutions during the seminar
- Participation in a workshop gathering Danish companies and Romanian district heating sector
- Unique possibilities for networking during both professional and social segments of the District Heating Days
